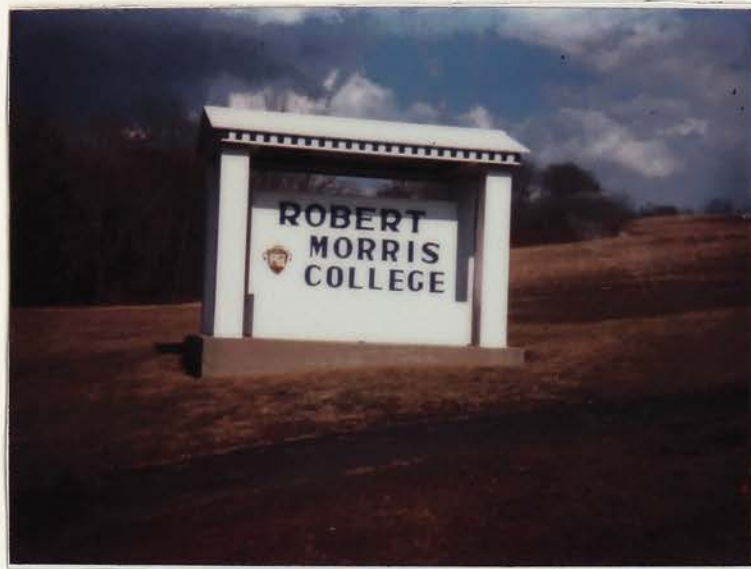





HISTORY OF ROBERT MORRIS COLLEGE

Robert Morris College was founded by Andrew Blass in 1921 as the Pittsburgh School of Accountancy. During the 1920's and 1930's, the Pittsburgh School of Accountancy was the first and only school in Pittsburgh to offer specialized professional instruction in Business Administration and Accounting. In 1935, the school was renamed the Robert Morris School in honor of the financier of the American Revolution. By 1962, Robert Morris School was approved by the state to grant associate degrees in Business Administration and the Secretarial Administration, becoming Robert Morris Junior College. In the same year, 230 acres were purchased in Coraopolis, near the Greater Pittsburgh Airport for the purpose of expanding the college. The Department of Education of the commonwealth of Pennsylvania granted the right to award the bachelor of science in the business administration degree to the college, the name was changed to Robert Morris College. The college received permission from the Department of Education in 1975 to prepare teachers of business and office education. In 1977, the State Department of Education granted the college the right to award the master of science degree in Taxation, Business Teacher Education, and Business Administration.

Robert Morris College continues in its proud tradition as one of the country's finest private business schools. It has an excellent reputation with area business corporations as virtually thousands of firms have employed Robert Morris College graduates.

HISTORY OF THE SCHOOL OF
BUSINESS ADMINISTRATION

In 1962, Robert Morris College was established as a junior college. At this time the purpose of the School of Business Administration was to "provide professional training in various fields of business and industry, and to give background education which should enable the student to advance rapidly into positions on the supervisory level." As a junior college, Robert Morris College offered three majors; Accounting, Management, and Marketing. To obtain a degree in any of these majors a student had to fulfill four requirements. These requirements were:

1. A student had to obtain a minimum of 115 credit hours in Accounting, 112 credit hours in Management, or 105 credit hours in Marketing.

2. These credit hours had to be earned in fulfilling a prescribed program in the School of Business Administration as listed in the catalog.

3. A student had to receive a passing grade in all subjects and achieve an average Quality Point Ratio of at least 2.0.

4. Of the credit hours required the student had to earn at least 40 at Robert Morris College.

In 1969, Robert Morris College established a senior college division. To graduate from the junior college division a student was required to complete all designated courses and earn a minimum of 60 credits with a cumulative Quality Point Average of at least 2.0. The final 30 credits had to be completed at Robert Morris College. To graduate from the senior college division a student was required to complete all designated courses including the courses comprising the major concentration. The student was required to complete all these courses with a minimum Quality Point Average of 2.0 earned in all courses. The final 30 credits of all programs must be completed at Robert Morris College. At this time the

School of Business Administration offered six majors. These majors were Accounting, Economics, Management, Marketing, Office Management, and Transportation. The stated purpose of the School of Business Administration was to direct its resources toward selected programs of study in administration for business leading to the baccalaureate degree.

Presently, Robert Morris College grants the bachelor of science in business administration degree (BSBA), the associate in science(AS) degree, and the associate in arts(AA) degree. Students who have completed a degree program with a cumulative grade average of C or better with at least a C in every course required for the major will be awarded the degree appropriate to the curriculum chosen.

Programs leading to the granting of the bachelor of science in business administration degree provide instruction and learning opportunities for undergraduates in the fields of accounting, athletic administration, business information systems, business teacher education, economics, hospitality administration, industrial communications, management, marketing, office administration, and transportation. Training in these fields is designed to develop competent business leaders who are fully aware of their social and civic responsibilities in the free and competitive enterprise economy of the nation.

Programs leading to the granting of the associate degree in business administration is designed to prepare students for lifelong learning and to qualify for entry into a career occupation. Robert Morris College students may elect to receive either, or both, the associate degree and the bachelor's degree. To qualify for a degree, candidates must successfully complete:

1. A minimum of 120 credits plus two credits of physical education for the bachelor of science in business administration

degree or a minimum of 60 credits plus two credits in physical education for the associate in arts or associate in science degree.

2. A cumulative Quality Point Average of at least 2.0 or higher where so specified for specific majors.

3. All designated courses.

4. A minimum grade of C in those courses designated as part of the major.

5. The 30-credit residency requirement of the College.

Robert Morris College is also authorized by the State Department of Education to award the master of science degree. The areas of graduate specialization are business administration, taxation, and business education.

Robert Morris College has grown a great deal in the last eight years. Since 1962 it has grown from a junior college to a college that has been granted the right to award the master of science degree.

Robert Morris College is an independent, nonprofit, coeducational institution, authorized by the Department of Education of the Commonwealth of Pennsylvania to award the master of science degree and the bachelor of science in business administration degree. The College is authorized also to award associate in arts and associate in science degrees to students who complete prescribed two-year programs.

The College is a member of the Middle States Association of Colleges and Secondary Schools, the Pennsylvania Association of Colleges and Universities, and the Association of American Colleges.

During the winter term in 1971, Rho Mu Chi Business Fraternity was founded on Robert Morris College's Moon Township Campus by Gerald Berenbaum, an assistant professor of accounting at the college. Being a Deltasig himself, Mr. Berenbaum realized the advantages of a chapter of Delta Sigma Pi on campus, and the benefits that it would bring to Robert Morris College, as well as Delta Sigma Pi. Rho Mu Chi remains the only professional business fraternity on campus today.

Mr. Berenbaum was the first faculty advisor for the fraternity, and his enthusiasm sparked the expansion and organization of the group throughout its first two years of existence. During 1973, the fraternity listened to numerous guest speakers in the marketing and management fields along with arranging a tour of General Motor's Fischer Body Plant in West Mifflin. The fraternity also won an award for outstanding achievement in services to the school. The campus was visited by then Executive Director, Charles Farran, in the fraternitie's first attempt to seek affiliation with Delta Sigma Pi. The fraternity also sponsored a basketball tournament playing the faculty members of Robert Morris College.

During the next two years the fraternity kept in constant correspondence with Delta Sigma Pi's central office in attempts by the group to go national, nearly succeeding one year except for lack of membership requirements.

In 1976, with Ray Dziki as President, Rho Mu Chi became a member of The Greek Council Organization. Six of the members were invited and attended the Mideastern Regional Conference of Delta Sigma Pi. On the professional scene, speakers included J. William McNeil of McNeil Associates, who spoke on business planning, and B. T. Richardson from Mobil Oil, whose topic was diversification by major oil companies. A canned food drive was conducted with the food being donated to a local catholic church. Socially, both Halloween and Christmas parties were successes. Fund raising events included the annual book sale held after every fall semester.

1977 was a year with a complete schedule of professional and community activities. The fraternity toured the Armco Steel Plant in Ambridge and Mobay's Chemical Laboratory in Robinson Township. The group sponsored speakers from The League of Women Voters, Jones and Laughlin Steel, and United States Steel. The fraternity, for the first time, took an active part in Greek Week, a week long gala of sport events promoting the brotherhood of all Greeks. Fund raisers included a pancake eating contest, with proceeds donated to Children's Hospital and The Heart Fund, a very successful bowl-a-thon, and a foul-shooting contest, along with the annual book sale. The group also sponsored a blood drive for Pittsburgh Blood Bank.

Rho Mu Chi adopted a formal pledge program similar to that of Delta Sigma Pi's pledge education program. In 1978, this program was further revised by Don Howard later in the year. The fraternity also updated its bylaws, charter, and

alumni members.

structure to provide more efficient and organized operation. This year marked the first Rho Mu Chi weekend held, which consisted of a formal, a picnic, and a party. The group also participated in a few fun ski trips, along with a camping trip to Kinzoo Dam. Professionally, Rho Mu Chi invited speakers from Bell Telephone and a major accounting firm. Participation in a national competition for Students in Free Enterprise included the design, advertisement and sales of t-shirts, and Hal Martin, past President, and Ellen Langa, Vice-President of Rho Mu Chi, represented RMC in the competition at Dallas where they won first place. Community efforts that year included distributing over 2500 voter fact sheets in Moon Township to encourage voter registration and participation.

The 1979 school year was highlighted by the RMC fall carnival, in which Rho Mu Chi took the most active part by raising the most money of any organization on campus. Chairmanned by Barb DiYanni, Rho Mu Chi's current President, it was a huge success. Proceeds were donated to the D. T. Watson Home for Crippled Children. The fraternity also supported a blood drive sponsored by Greek Council and held a fund drive for a terminally ill member of RMC's staff. Fund raising for the fall semester included a \$100 raffle, a coupon book sale, and the beginning of our most successful bagel sale, which is now a monthly event. The fraternity took time out of its busy schedule to attend a boat ride sponsored by Greek Council and the Snowball, a formal dance sponsored by the Student Government. Our own Christmas party was a huge success, attended by numerous alumni members.

The main event planned by Rho Mu Chi Fraternity in the winter 1980 term, is its induction into the International Fraternity of Delta Sigma Pi, and many efforts are being expelled for this memorable and honorable happening. Some of the events of the semester include the Muscular Dystrophy Dance Marathon, chairmanned by Rho Mu Chi's Tom Necastro, a pizza eating contest, a speaker from Arco, a tour of a local steelmill, participation in the moot court trials, various fund raisers, and numerous other activities.

Professional day and T-shirt day are held once a month by the fraternity. On these days, each member dresses in professional attire for professional day or wears their Rho Mu Chi t-shirts to set examples to others--our purpose for existing and the brotherhood which is present among us.
